Explain when LAPD switched to the newer email system.

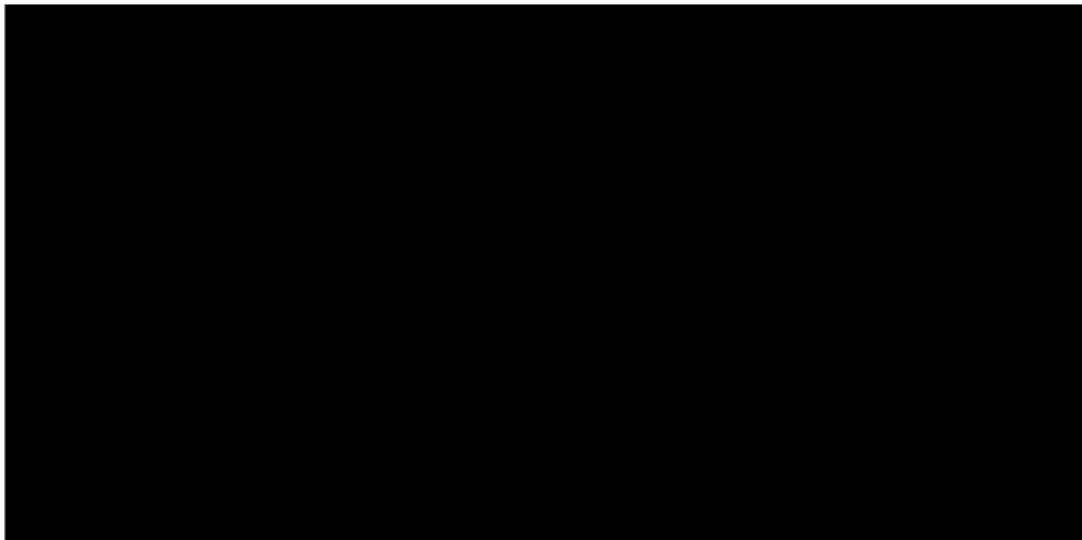
We switched in June of 2016 and retrieved 6 months' worth of a user's emails from GroupWise. Our migration was 6 months long so depending on when you migrated, your email in the new Office 365 account would start sometime between January and June of 2016.

The issues that occurred with the old emails

We had a system error last summer in August 2019 and had to completely recover the SQL server that houses the index information for the Archive system.

You have attempted to fix the issues but can't, and that it seems to affect a random set of emails.

We recreated the SQL server based on backups we had of the database and so we are able to search again but do not have backups of all the actual email data in the SAN so what comes up as errors is unavailable. We no longer have a contract with MicroFocus.
